

## Take Me Out to the Travelers Game! Official Contest Rules

## 1. THE CONTEST.

The Arkansas Scholarship Lottery wants you to enjoy a fun night out with family or friends at the Arkansas Travelers baseball game against the San Antonio Missions May 2, 2024! Comment to let us know your favorite baseball game snack, and you're entered to win a prize pack with four tickets, four hot dogs, four drinks, and swag from the Lottery.

- 2. ENTRY PERIOD. Entry for this contest will open when the contest entry assets go live on Facebook and Instagram on Wednesday, April 24, 2024 at approximately 11:59 a.m. CDT. The entry period will close at 11:59 a.m. CDT on Friday, April 26, 2024.
- 3. HOW TO ENTER. To enter, comment on the entry posts on Facebook and Instagram to share your favorite baseball game snack. Limit one entry per valid Facebook user and one entry per valid Instagram user.
- 4. CONTEST ELIGIBILITY. This contest is open to Facebook and Instagram users 18 years of age or older. Winners must reside in Arkansas. The following are not eligible to enter the contest: Individuals who are incarcerated in the Department of Correction, the Department of Community Correction, or a county or municipal jail or detention facility; an employee of the Office of the Arkansas Lottery or their immediate family members living in the same household as the employee; any officer, employee, agent or subcontractor of an Office of the Arkansas Lottery vendor, or immediate family of the officer, employee, agent, or subcontractor of an Office of the Arkansas Lottery vendor if that officer, employee, agent, or subcontractor has access to confidential information that may compromise the integrity of a lottery. Immediate family or immediate family members shall include father, mother, sister, brother, husband, wife, child, grandmother, grandfather, grandchild, father-in-law, mother-in-law, sister-in-law, brother-in-law, son-in-law,

daughter-in-law, stepchild, grandmother-in-law, grandfather-in-law, step grandchild, or any individual acting as parent or guardian.

- 5. PRIZE WINNER SELECTION. After the entry period for the contest ends, comments will be downloaded. Each commenter will be assigned a number. Google's random number generator will be used to select a winner for each platform. Winners will be notified via Facebook Messenger and Instagram Direct Message. If a prize is not claimed within 24 hours, another random winner will be chosen until the prize is claimed. A valid Arkansas mailing address is required in order to claim and receive a prize.
- 6. PRIZES. One winner on Facebook and one winner on Instagram will receive a Prize Pack including four (4) reserved tickets to the Thursday, May 2 Arkansas Travelers game against the San Antonio Missions, four (4) drinks, four (4) hot dogs, and ARSL swag.
- 7. PRIZE LIMITATIONS. Contest prizes are awarded in "as is" condition. Prizes may not be substituted for another or monetary value.
