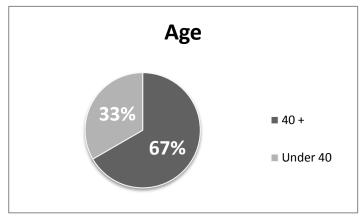

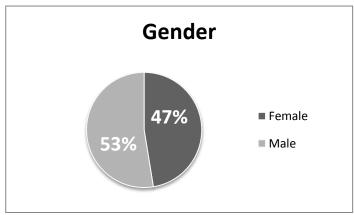

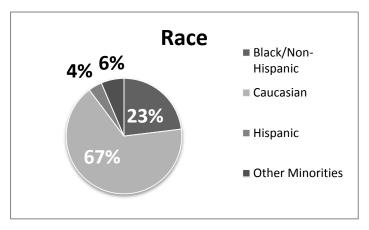

Arkansas Lottery Commission – Internal Audit Arkansas Lottery Commission Legislative Oversight Committee Monthly Report March 10, 2014

On February 19, 2014, the Arkansas Lottery Commission Internal Auditor (Internal Audit) presented results of the Financial Accounting & CAFR and Instant Ticket Reconstructions Audits to members of the Arkansas Lottery Commission (ALC).

Financial Accounting & CAFR Audit

The audit centered on controls, procedures, and processes that ensure that ALC Management adopts accounting policies that are in compliance with applicable Governmental Accounting Standards Board (GASB) standards, and that such policies result in a Comprehensive Annual Financial Report (CAFR) that complies with those standards and guidance issued by the Government Finance Officers Association (GFOA). Fieldwork included review of documentation and information generated in fiscal years 2013 and 2014, with primary focus on the ALC's CAFR for the year ended June 30, 2013.

The following observation was reported to members of the ALC:

 In evaluating the statistical and supplementary sections of the CAFR for both years, six inaccuracies in schedules presented in these sections of the CAFR for June 30, 2012 and one inaccuracy in schedules presented in these sections of the CAFR for June 30, 2013.

The inaccuracies noted included mathematical errors and inconsistencies when comparing information presented in these schedules to underlying supporting documentation, and a complete list of June 30, 2012 inaccuracies noted by Internal Audit were provided to ALC Management in advance of completion of the CAFR for June 30, 2013 so that any necessary actions could be taken to prevent similar inaccuracies from appearing in the June 30, 2013 CAFR. ALC Management took immediate action to address these items, as applicable. Internal Audit recommended that ALC Management continue to perform detailed review of information presented in supplementary and statistical schedules presented in the CAFR, particularly information that is included in these schedules that is provided to the ALC by other state agencies. ALC Management responded stating that it concurs with Internal Audit's recommendation.

Instant Ticket Reconstructions Audit

The audit centered on controls, procedures, and processes that ensure that instant ticket reconstruction requests are authorized and reasonable given the circumstances that might give rise to a reconstruction request. Fieldwork included review of documentation and information generated in fiscal years 2013 and 2014.

The following observation was reported to members of the ALC:

 No formal monitoring or review by ALC Management of the reconstruction requests sent to Scientific Games on a monthly or similar periodic basis, and one reconstruction request for which it cannot be demonstrated that ALC personnel had viewed the instant ticket in question or had physical custody of the instant ticket.

Normally in response to player claims, instant tickets must sometimes be reconstructed to affirm if the tickets presented to the ALC for payment are indeed winning tickets because such tickets were damaged to the point that the ALC cannot validate the tickets presented through normal methods. Reconstruction requests must be processed by the ALC's instant ticket vendor, Scientific Games, to ensure the integrity of instant ticket games are protected. Without viewing or having physical custody of a ticket that is subsequently reconstructed, the ALC has no method for validating that a ticket has actually been purchased or that the request to reconstruct is being performed to determine if a ticket is a winner without the ticket being scratched and/or rendered into a condition where it cannot be subsequently sold to an unsuspecting individual.

Arkansas Lottery Commission – Internal Audit Arkansas Lottery Commission Legislative Oversight Committee Monthly Report March 10, 2014

Internal Audit recommended that ALC Management implement a process of weekly or monthly review of all reconstruction requests and that no future reconstruction requests be logged in instances where a questioned instant ticket or other supporting documentation has not been viewed by the employee that requests the reconstruction, to avoid the potential for unnecessary reconstructions. ALC Management responded stating that physical receipt of the ticket to be reconstructed or other supporting documentation will be required for all future reconstruction requests, that Management approval will be required for all future payments to players resulting from reconstructions, and that Management will perform a monthly review of reconstruction requests by user going forward.

For both observations noted above, additional follow-up procedures are necessary for Internal Audit to consider them cleared. The Arkansas Lottery Commission Legislative Oversight Committee will be kept apprised of the results of follow-up procedures, once they are completed.

No additional items have been reported to the Arkansas Lottery Commission since the previous report submitted to the Arkansas Lottery Commission Legislative Oversight Committee on February 10, 2014.
