Arkansas Lottery Commission Term Contracts for Goods and Services December 1 through December 31, 2014

- 1. On December 1, 2014, a 60-month Government Product Lease Agreement was executed between the Arkansas Lottery Commission and MailFinance. The purpose of the agreement is for the leasing of Model # IH600HF postage meter equipment and meter rental. Monthly payment (plus sales tax) is \$97.91, billed quarterly, for a total payment of \$5,874.60 plus tax.
- 2. On December 1, 2014, a Service Agreement was executed between the Arkansas Lottery Commission and Lineage for service maintenance on Model # IH600HF postage meter. The term of the service agreement is for 60 months at \$26.40 plus tax per month, billed annually, for a total cost of \$1,584.00 plus tax.
- 3. On December 9, 2014, A Second Amendment to the Agreement for Contractual Services for Instant Ticket Lottery Game Services was executed between the Arkansas Lottery Commission and Scientific Games International, Inc. The amended agreement lowered the Properties Plus loyalty program percentage allocation from the instant ticket prize structures to 1.35% (from 1.5%). The amendment was reviewed by the ALCLOC on December 5, 2014, and the new rate of 1.35% began on the date of execution.
- 4. On December 19, 2014, a First Amendment to the Agreement for Contract Services for Outdoor Advertising was executed between the Sunshine Electronic Display Corporation ("Sunshine") and Mangan Holcomb Corporation ("MGH") on behalf of the Arkansas Lottery Commission ("ALC"). The purpose of the agreement is for the leasing of thirty-two (32) jackpot displays of various sizes. The displays will be attached by Sunshine to sixteen (16) billboards leased through MGH. The following information is provided:
 - a. Date of Agreement: December 19, 2014.
 - b. Terms of Agreement: The initial term shall be six (6) consecutive calendar months, commencing January 1, 2015, and continuing through June 30, 2015. MGH will pay Sunshine \$265.00 plus sales tax per month for each display. MGH will then invoice ALC monthly for the jackpot displays.
 - c. Vendor or other parties to the Agreement: Sunshine Electronic Display Corporation, Mangan Holcomb Corporation, and Arkansas Lottery Commission.
 - d. Value (cost or cost savings projected for the agreement): \$265.00 per month plus sales tax for thirty-two (32) signs for six months, or \$50,880.00 plus sales tax.

5. On December 22, 2014, a Non-Exclusive Licensing Agreement was executed between Scientific Games International, GTECH Corporation, and the Arkansas Lottery Commission. The Agreement allows the ALC to reproduce, use and make copies of the Property in association with the sale, marketing, advertising and promotion of a scratch-off instant win lottery game to be conducted by the ALC and identified as AR-283 Bejeweled®. A copy of the agreement was provided to the Arkansas Lottery Commission Legislative Oversight Committee on January 8, 2014.

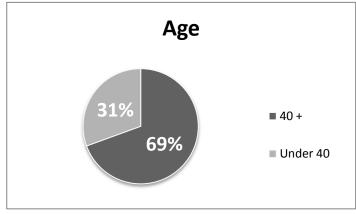

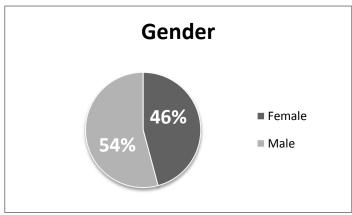

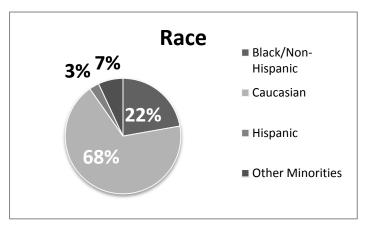

Arkansas Lottery Commission – Internal Audit Arkansas Lottery Commission Legislative Oversight Committee Monthly Report January 9, 2015

No issues or problems resulting from internal audits have been reported to the Arkansas Lottery Commission since the previous report submitted to the Arkansas Lottery Commission Legislative Oversight Committee on December 10, 2014.

As required by Arkansas Code Annotated § 23-115-212 (c) (1) (B), the Arkansas Lottery Commission Internal Auditor is required to update the Arkansas Lottery Commission Legislative Oversight Committee regarding resolution of the Division of Legislative Audit's findings included in the annual financial report for the Commission. On December 29, 2014, the Division of Legislative Audit (DLA) released its report for the fiscal year ended June 30, 2014 under early release procedures. The report has not yet been formally presented to the Legislative Joint Auditing Committee.

DLA's Report on Internal Control over Financial Reporting and on Compliance and Other Matters includes the following findings:

DLA Finding 2014-1:	During review of payroll and other related items, we noted seven employees working schedules that fall outside the Agency's normal business hours. Six employees had either an offer letter or some other form in their personnel file documenting their scheduled working hours; however, there was no documented working schedule for the Agency Director. We also noted that the Agency does not have a Commission approved policy for alternate work schedules, and none of the alternate working schedules appear to have been approved by the Governor. Governor's Policy Directive #5 states, "All State offices shall be open for business between 8:00 a.m. and 4:30 p.m. However, department directors shall have flexibility to establish other working hours for their department personnel so long as all employees work an eight-hour day. Deviations from the five day, 40-hour work week shall be approved by the Governor." We recommend the Agency seek an Attorney General's opinion as to whether the Agency is exempt from Governor's Policy Directive #5. We further recommend the Agency adopt a written policy regarding alternate working schedules and obtain approval from the Commission and/or the Governor.
ALC Management Response:	The ALC will review the finding and determine whether to change policy to conform with the finding or to seek an Attorney General's opinion.
ALC Internal Audit Update:	ALC Management continues to review the finding and has not yet taken any further action.

DLA Finding 2014-2:	Travel regulation R1-19-4-903 states that when privately-owned motor vehicles are used for official business travel, the traveler may claim reimbursement at the rate per mile established by the Chief Fiscal Officer (CFO) of the State in effect during the time the travel occurred. On January 15, 2014, the Commission authorized an increase in the mileage reimbursement rate for Agency employees from \$0.42 per mile to \$0.56 per mile. During review of travel reimbursements, we selected five marketing sales representatives for testing. For those five employees, the increased rate in mileage reimbursement for the period of January 15 - June 27, 2014, resulted in a total additional cost to the Agency of \$6,535. We recommend the Agency seek an Attorney General's opinion as to whether the Agency is exempt from the reimbursement rate per mile established by the CFO of the State. If the Attorney General opines that travel regulation R1-19-4-903 applies to the Agency, we recommend the Agency reduce the mileage reimbursement rate to \$0.42 per mile, as established by the CFO of the State. We further recommend the Agency seek reimbursement from all affected employees for all amounts reimbursed above the authorized rate.
ALC Management Response:	The ALC will review the finding and determine whether to change policy to conform with the finding or to seek an Attorney General's opinion.
ALC Internal Audit Update:	ALC Management continues to review the finding and has not yet taken any further action.
