



Guess the Ticket!
Official Contest Rules

1. **THE CONTEST.** The Arkansas Scholarship Lottery is giving away a \$100 scratch-off bundle and Arkansas Scholarship Lottery merch! We've hidden a fun scratch-off in a fall photo — think you can guess which one? Comment the correct ticket name, and you could be entered for a chance to win.

2. **ENTRY PERIOD.** Entry for this contest will open when the contest entry asset goes live on Facebook on Mon., Nov. 3, 2025, at approximately 9 a.m. CST. The entry period will close on Wed., Nov. 5, 2025, at 11:59 p.m. CST.

3. **HOW TO ENTER.** To enter, comment the correct name of the ticket hidden in the photo. Limit one entry per valid Facebook user.

4. **PRIZE WINNER SELECTION.** After the entry period for the contest ends, comments will be downloaded. Each commenter with the correct ticket name will be assigned a number. Google's random number generator will be used by the advertising agency of record for ASL, CJRW, to select the winner. Winner will be notified via Facebook Messenger. If a prize is not claimed within 24 hours, another random winner will be chosen until the prize is claimed. A valid Arkansas mailing address is required in order to claim and receive a prize.

5. **PRIZES.** One winner will receive a \$100 scratch-off bundle and Arkansas Scholarship Lottery merchandise by mail for an estimated total value of \$200.

6. **CONTEST ELIGIBILITY.** This contest is open to Facebook users 18 years of age or older. Winners must reside in Arkansas. The following are not eligible to enter the contest: Individuals who are incarcerated within a Division of Correction facility, the

Division of Community Correction, or a county or municipal jail or detention facility; an employee of the Office of the Arkansas Lottery or their immediate family members living in the same household as the employee; any officer, employee, agent or subcontractor of an Office of the Arkansas Lottery vendor, or immediate family of the officer, employee, agent or subcontractor of an Office of the Arkansas Lottery vendor if that officer, employee, agent or subcontractor has access to confidential information that may compromise the integrity of a lottery. Immediate family or immediate family members shall include father, mother, sister, brother, husband, wife, child, grandmother, grandfather, grandchild, father-in-law, mother-in-law, sister-in-law, brother-in-law, son-in-law, daughter-in-law, stepchild, grandmother-in-law, grandfather-in-law, step grandchild or any individual acting as parent or guardian.

7. **FACEBOOK DISCLOSURE.** This promotion is in no way sponsored, endorsed, or administered by or associated with Facebook. You understand that you are providing your information to the organizers and not to Facebook. The information you provide will only be used as outlined above in the **PUBLICITY** section herein.

10. **RELEASE.** To the fullest extent permitted by law, in exchange for the opportunity to enter and participate in the competition and win the prize, you (for yourself), your heirs, next of kin, administrators and executors forever waive, release and hold harmless (“RELEASE”) any and all rights, claims, damages, liabilities, costs, attorneys’ fees, expenses and causes of action whatsoever (“CLAIMS”) that you may have against the sponsor, the competition vendors and suppliers, its affiliates, employees and agents, vendors and suppliers, the judges, prize providers and each of their respective related entities (The “RELEASED PARTIES”), and each such released parties’ officers, directors, employees and agents. - C. Nothing in these rules or the contest shall be construed as a waiver of the state's sovereign immunity.
- D. Exclusive venue regarding this contest involving any disputes with the Office of the Arkansas Lottery/Arkansas Scholarship Lottery shall be resolved in Pulaski County, Arkansas.
