# Arkansas Department of Finance and Administration Office of the Arkansas Lottery <br> Contracts for Goods and Services <br> August 1 through August 31, 2015 

On August 13, 2015, the Department of Finance and Administration Office of the Arkansas Lottery (OAL) and Advent Systems, Inc. (Advent), entered into a First Amendment to the Security System Equipment and Maintenance Agreement. The purpose of the amendment was to ensure the continuity of security system equipment maintenance and service, pursuant to the agreement entered into between the parties (the Contract) on June 4, 2013. The following information is provided:
a. Date of Agreement: August 13, 2015.
b. Terms of Agreement: One (1) year, effective as of September 1, 2015, with an option for renewal at a mutually agreed-upon price up to five (5) times in one (1) year increments or a portion thereof.
c. Vendor or other parties to the Agreement: Advent Systems, Inc. and Department of Finance and Administration Office of the Arkansas Lottery
d. Value (cost or cost savings projected for the agreement):

Service Agreement cost from September 1, 2015, through August 31, 2016, is $\$ 18,624.83$. Service calls for items not listed on the Equipment List or Service Calls that are due to OAL designated representative error or neglect will be billed at $\$ 65.00$ per hour. Advent will charge the after-hours rate of $\$ 97.50$ per hour for all work performed between the hours of 5:30 p.m. and 7:00 a.m., Monday through Friday and between 8:00 a.m. and 4:30 p.m. Saturday with a minimum charge per call of $\$ 195.00$.

Office of the Arkansas Lottery - Internal Audit Arkansas Legislative Council - Lottery Oversight Subcommittee Monthly Report

On September 3, 2015, the Office of the Arkansas Lottery (OAL) Internal Auditor (Internal Audit) issued a report to the Director of the Department of Finance and Administration (DFA Director) as follows:

## Retailer Settlement and Collection Audit

The audit centered on controls, procedures, and safeguards surrounding the OAL's settlement and collection of cash from its retail partners. Fieldwork included review of documentation and information generated July 1, 2014 through July 7, 2015.

The following observation and recommendation was reported:

- Retailer Credit Balances - Settlement - Retailers with net credit balances are granted disbursement of the amounts owed to them by the OAL semi-annually, while retailers with net debit balances (i.e. that owe money to the OAL) are given the benefit of any credits due them on a weekly basis.

Internal Audit recommended that OAL Management reconsider the policy of semi-annual credit balance refunds and provide them more often (such as monthly), considering that accumulation of a net credit balance likely results in part from other OAL retailers not maintaining adequate cash balances or other measures to pay players with winning tickets up to the cashing limit. Internal Audit further recommended that the updated policy be communicated to the OAL retailer network, should any changes be implemented. OAL Management stated its concurrence with the Internal Audit recommendation, stating that a policy of quarterly reimbursements for large chains and major retailers with location-level credit balances of $\$ 2,000$ or more will be instituted and that such policy will be communicated to retailers impacted via an e-mail message. Internal Audit expects the first disbursement of credit balances to impacted retailers will occur in December 2015, and will perform follow-up procedures in order to consider the observation cleared at the appropriate time.

On September 4, 2015, Internal Audit issued a report to the DFA Director as follows:

## Advertising Contract Compliance Follow-Up Audit

Internal Audit reported to the DFA Director that follow-up audit procedures were performed relative to Advertising Contract Compliance, and that Internal Audit's observations from the initial audit of this process (reported to the Arkansas Legislative Council - Lottery Oversight Subcommittee on June 10, 2015) are now considered cleared based on OAL Management's corrective action or moot given that certain procurement functions are now handled by the Office of State Procurement rather than OAL personnel.

No additional issues or problems resulting from internal audits have been reported to the Director of the Department of Finance and Administration for the reporting period.
