Arkansas Lottery Commission Term Contracts for Goods and Services June 1 through June 30, 2012

- 1. On June 8, 2012, a Non-Exclusive Licensing Agreement was executed between the Arkansas Lottery Commission (ALC) and Scientific Games International (SGI). SGI grants the ALC the non-exclusive right in the state of Arkansas to reproduce, use and make copies of the Property in association with the sale, marketing, advertising and promotion of a scratch-off instant win lottery game to be conducted by the ALC and identified as AR-157 Family Feud[®]. A copy of the agreement was provided to the Arkansas Lottery Commission Legislative Oversight Committee.
- 2. On June 28, 2012, ALC entered into an amended agreement ("First Amendment to the Agreement for Contractual Services for Instant Ticket Lottery Game Services") to the August 25, 2009, Scientific Games International Instant Ticket Contract for the remainder of the contract term. A copy of the agreement was provided to the Arkansas Lottery Commission Legislative Oversight Committee.

2. Retailer losses for period June 1 through June 30, 2012: One (1) account: Retailer No. 100341, Twin Lakes Mobile Home and Pawn, in the amount of \$3,111.32.

Due to their age and probability of their collection, certain retailer balances have been charged as losses during June 2012 for financial accounting purposes. These losses have accordingly been charged against the retailer Fidelity Fund reserve. The retailer Fidelity Fund is a reserve account established for the lottery by statute, and funded by an annual fee charged to all licensed lottery retailers. These losses will not impact lottery proceeds. The write-off of these balances to the reserve account for accounting purposes, does not diminish the Lottery's legal ability to continue to pursue collection, and attempts to collect these amounts will continue through all avenues available to the lottery.

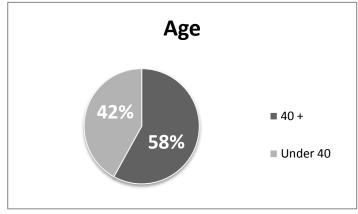

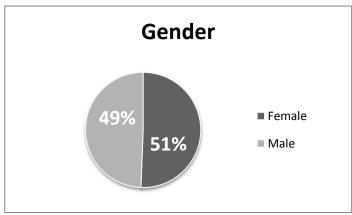

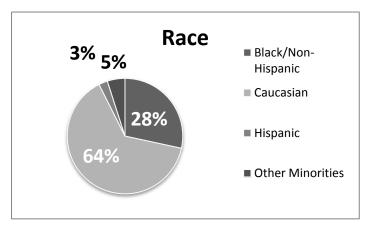
