Arkansas Lottery Commission Term Contracts for Goods and Services February 1 through February 28, 2013

1. On February 4, 2013, the Arkansas Lottery Commission ("ALC") and Advent Systems, Inc. entered into a Security Equipment Service Agreement for service to ALC's Claim Centers. These Claim Centers are located in Little Rock, Camden, Jonesboro and Springdale. The agreement is for a period of six (6) months, from January 1, 2013, through June 30, 2013. Service includes: (1) Scheduled Maintenance Visits; (2) Software Maintenance; (3) Hardware Repair Service; (4) Instant Loaner; (5) On-Call Telephone Support; (6) Emergency Services; (7) Service Calls; and (8) Off-Hour Support. The total amount for the six-month period is \$19,486.00.

2. On February 22, 2013, ALC entered into a Non-Exclusive Licensing Agreement with Scientific Games International to allow ALC to reproduce, use and make copies of "American Muscle®" licensed property. A copy of the agreement was provided to the Arkansas Lottery Commission Legislative Oversight Committee on February 28, 2013.


