RE: Notice of Execution of Licensing Agreement

Gentlemen:

In accordance with the letter of December 14, 2010, from the previous Co-chairs of the Arkansas Lottery Commission Legislative Oversight Committee, please consider this letter and the attachment as notice of the execution on July 11, 2013, of a Non-Exclusive Licensing Agreement between Scientific Games International ("SGI"), Alchemy3 LLC, through SGI ("Alchemy"), and the Arkansas Lottery Commission ("ALC"). The non-exclusive licensing agreement allows the ALC to reproduce, use, and make copies of Instant Game No. AR-200 Bass Pro Shops® licensed property.

- 1. Date of Agreement: July 11, 2013.
- 2. Term of Agreement: The term of this agreement shall commence on the date the Working Papers for the Game are signed and shall expire on the last day for claiming Game prizes as established by the ALC.
- Vendor or other parties to the Agreement: ALC, SGI and Alchemy (through SGI).
- 4. Value (cost or cost savings projected for the agreement): The base instant game contract price is 1.8100% of net sales. There is a price of \$.89 per 1000 tickets for FailSafe Barcode Services and a price of 1.5% of the prize fund for Points for Prizes Rewards/Merchandise Prizes and Fulfillment. The preceding costs are standard for all ALC instant games. Additionally, SGI shall invoice ALC, on behalf of Alchemy, in the amount of One Hundred Fifty Thousand dollars (\$150,000.00) for three hundred (300) five hundred dollar (\$500.00) custom-designed Bass Pro Shops® gift cards. SGI shall invoice the ALC, on behalf of Alchemy, in the amount of Forty-One Thousand Two Hundred Ninety-Seven dollars and twenty-eight cents (\$41,297.28) for one (1) Nitro® Boat as detailed in the licensing agreement.
- 5. There is a program fee for the use of the Bass Pro Shops® PROPERTY one point seventy-five percent (1.75%) of the potential sales for the GAME. This fee will not be determined until the final ticket quantity is delivered to the ALC.
