**ALTERATION OF ORIGINAL RFQ/RFP DOCUMENTS:** The original written or electronic language of the RFQ/RFP shall not be changed or altered except by approved written addendum issued by the Office of State Procurement. This does not eliminate an offeror from taking exception(s) to these documents, but does clarify that the offeror cannot change the original documents written or electronic language. If the offeror wishes to make exception(s) to any of the original language, it must be submitted by the offeror in separate written or electronic language in a manner that clearly explains the exception(s). If the offerors contract submittal is discovered to contain alterations/changes to the original written or electronic documents, the offerors response may be declared as non responsible and the response shall not be considered.

The Arkansas Lottery Commission objects to and shall not consider any additional terms or conditions submitted by a vendor, including any appearing in documents attached as part of a vendor's response to this RFP. In signing and submitting its proposal, a vendor agrees that any additional terms or conditions, whether submitted intentionally or inadvertently, shall have no force or effect. Failure to comply with terms and conditions, including those specifying information that must be submitted with a RFP, shall be grounds for rejecting a proposal.

**SCOPE:** The ALC is seeking a printer to print a Powerball sticker with the following specifications:

- The sticker, a copy of which is attached, is 4.5 x 4.5 inches
- The sticker should be printed on white gloss paper and be able to hold ink from a marker
- Quantity – 100,000 copies
- Flexo printed roll labels – rolls of 1,000
- Customer will supply print ready art
- Printed four color process with bleed
- The ALC prefers that the sticker be printed using recycled paper, if possible. A preference of ten percent (10%) will be given for vendors that submit quotes which include the use of recycled paper.
- Soybean oil ink must be used and the brand name of the ink must be listed by the vendor
- Receipt of the finished product does not constitute acceptance
- FOB inside delivery
- Delivery will be expected within one (1) week of the award of the contract
