

**ALC Response to Questions Submitted by Crowe Horwath, LLP related to
ALC RFQ -110001**

1. Is this the first year that the Arkansas Lottery Commission will be completing a Comprehensive Annual Financial Report (CAFR)?

ALC Response: Yes.

2. On page 12 of the RFQ, the ALC states that they will make financial records available to complete the CAFR. What is the current accounting system used by the ALC and will the general ledger/trial balance be available electronically in Microsoft Excel?

ALC Response: The financial system used by ALC is Peachtree Quantum. Yes, all reports are available in Excel format.

3. Will historical financial, revenue, debt demographic and operating (as applicable) data be provided for the past 10 years to compile the statistical section of the CAFR or does the ALC view this as a responsibility of the vendor?

ALC Response: As of June 30, 2011, ALC will have completed two fiscal years since creation of ALC. All historical data will be available to the vendor. The vendor will be responsible for using the historical data to prepare all historical statistical data and graphs.

4. The RFQ does not reference a Management Discussion and Analysis (MD&A). Is it ALC's expectation that ALC will complete the MD&A for the CAFR?

ALC Response: This will be the responsibility of the vendor. Assistance in obtaining the information will be given by ALC employees.

5. Will the Statement of Cash flow information be provided to the vendor to compile the Statement or is it ALC's expectation that the Statement of Cash Flows be completed entirely by the vendor?

ALC Response: The Statement of Cash flows will be prepared by ALC employees and will be audited by the Arkansas Department of Legislative Audit.

6. Though the ALC is presented as one major proprietary fund for the purposes of financial reporting, does the ALC expect to include other combining schedules of their components/departments in the CAFR?

ALC Response: The CAFR will be for ALC operations only.

7. The RFQ requests a draft CAFR by October 1st. What is the ALC's expected date to provide the final financial records for the fiscal year to the vendor (i.e. what will be the vendors turnaround time to complete the draft CAFR)?

ALC Response: The final financial records for the fiscal year will be available upon the completion of the annual audit performed by the Arkansas Department of Legislative Audit. The expected completion date is October 24th, 2011. The October 1st draft will be based upon preliminary financial data and will be revised as necessary upon the completion of the audit.

8. Will the allocation of depreciation to the appropriate business-type activities be provided to the vendor or is it the expectation of the ALC that the vendor will work with the ALC to allocate those charges to the appropriate activities?

ALC Response: The vendor will work with ALC to allocate any necessary depreciation.

9. Will the ALC be providing the 10 year historical data to complete the Scheduling of Funding Progress and the Employer Contribution Required Supplemental Schedules for the ALC's Pension and OPEB plans?

ALC Response: ALC has been in operation for two years and will provide all requested information. The vendor will be responsible for preparing all historical statistical information.

10. What is the expected timing of the training described in Section 4 of the RFQ? Does the ALC envision that this will occur as the CAFR is being completed or at some point after the CAFR is finalized?

ALC Response: The training should be completed by the vendor to meet all deadlines outlined in the RFQ. ALC envisions this training will occur as the CAFR is being completed.

11. The RFQ references the need to use soybean oil ink. How has this requirement been met in the past by ALC? Who has responsible for printing in the past to meet this requirement?

ALC Response: A list of known companies that can satisfy this requirement is attached.

12. Page 12 item number 7 references the ALC monthly report and Attachment G. However, no attachment G was noted in the RFQ packet. Could the ALC please provide an example of one of the monthly reports?

ALC Response: Yes. See attached.

13. Does ALC have a budget for this project? If so, what is the budget?

ALC Response: No.

14. Does ALC envision that the financial information provided to the vendor to complete the CAFR will be final and include any and all audit adjustments or does the ALC envision the vendor to assist with any year-end close entries or to adjust/update the CAFR for audit adjustments?

ALC Response: Yes, preliminary and audited final numbers will be available to the vendor. The vendor will not be involved with any year-end close entries.

15. Can ALC provide a listing of qualified M/WBE firms?

ALC Response: See attached Small and Minority Business Directory from the Arkansas Economic Development Commission website.
