### ADDITIONAL SPECIFICATIONS

- **Add the following to the bottom of Sub-Section 3.12:**

Performance Security may be satisfied with an irrevocable letter of credit. A letter of credit **must** be for a two-year maturity, commensurate with the two-year contract. If the contract is extended beyond two years, the letter of credit **must** be extended for the commensurate period. The Vendor is responsible for payment of fee(s) associated with procuring a letter of credit.

- **Add the following to Sub-Section 1.8 (A):**

5. **DO NOT** submit prices with the Technical Proposal Packet. Pricing will be negotiated with the top ranked vendor.

### CHANGE OF SPECIFICATIONS

- **Delete Sub-Section 3.9 (I) and replace with the following:**

- I. A disclosure of all the states and jurisdictions in which the Vendor has Contracts to provide gaming goods or services of any kind relating to the State lottery, including without limitation all lottery goods and services, and the nature of the goods or services involved for each state or jurisdiction.

- **Delete Sub-Section 3.10 and replace with the following:**

Vendor **must** include in its proposal a complete disclosure of any civil or criminal litigation or indictment involving such Vendor, and the Vendor **must** also disclose any civil or criminal litigation or indictment involving any of its joint ventures, strategic partners, prime contractor team members, and subcontractors. The disclosure **must** be at least for the time period of January 1, 2013 to the present and **must** include the case name, number and jurisdiction, date of filing and case disposition (ex: pending; settled; dismissed, other (please explain)). This disclosure requirement **shall** be a continuing obligation, and any litigation commenced after a Vendor has submitted a proposal under this RFQ **must** be disclosed to the OAL in writing within five (5) days after the litigation is commenced.

- **Delete the Technical Proposal Packet and replace with the Revised Technical Proposal Packet dated 7/7/2015.**
- **Delete Sub-Section 1.4 – (No replacement)**

The specifications by virtue of this addendum become a permanent addition to the above referenced RFQ. Failure to return this signed addendum may result in rejection of your proposal.
